Dear Mr. President,

A year ago, on January 13, 2012, the well-known Philippine human rights activist Temogen "Cocoy" Tulawie was arrested by security forces in Davao/Mindanao.

He is accused of having prepared an attempt on the life of Sakur Tan, Governor of the Province of Sulu. Together with many national and international partners, the Action Network Human Rights-Philippines (Aktionsbündnis Menschenrechte-Philippinen – AMP) is convinced that the accusations against Mr. Tulawie have been made up in order to silence this activist, who has documented and made public violations against human rights in Sulu for many years.

All witness statements, on which the indictment is based, are forced and have in the meantime been withdrawn. Due to his work as human rights activist, Mr. Tulawie was massively threatened in Sulu, so that he had to hide away until his arrest.

In the wake of the attempted relocation of his process to Manila by Governor Tan, Mr. Tulawie was again threatened with death. According to reports, imprisoned violent criminals have already been ordered to murder Mr. Tulawie upon his arrival at the prison of Bicutan. Therefore, it must be feared that Mr. Tulawie's life is in danger, should he be transferred to the prison of Bicutan.

On the anniversary of Mr. Tulawie's arrest we call on the Government of the Philippines to spare no effort to protect the life and health of this human rights activist.

The relocation of the trial to Manila should be reversed, as it is a further delay of the process as a whole and a huge threat to Mr. Tulawie's life.

Furthermore, we expect a fair and speedier trial against Mr. Tulawie in order to refute the alleged accusations against him once and for all. We expect the Philippine Government to set up an independent investigative committee to clear up the many cases of criminalization of human rights defenders quickly and comprehensively.

Mr. President Aquino, we strongly request you to act in compliance with the UN Declaration of Human Rights Defenders! Procure that human rights defenders get the protection from the government they are entitled to, so that they are able to fulfil their important tasks.
